

## Have you received a ticket issued by the Bylaw Officer?

The Town of Vermilion initially issues a Vermilion Tag for Bylaw fines. If this Tag is not paid a Provincial Ticket is issued in its place which is prosecutable in Provincial Court.

\*\*\*Please note: Once a Provincial ticket is issued all payments must be made to the Provincial Court.\*\*\*
