WHEREAS the lands hereafter described are no longer required for public travel, and

WHEREAS application has been made to Council to have the highway closed, and

WHEREAS the Council for the Town of Vermilion deems it expedient to provide for a By-Law for the purpose of closing to public travel certain roads, or portions thereof, situated in the said municipality, and thereafter selling same, and

WHEREAS Notice of the Intention of Council to pass a By-law has been given in accordance with Section 606 of the Municipal Government Act, and

WHEREAS Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the By-Law.

NOW THEREFORE BE IT RESOLVED that the Council for the Town of Vermilion does hereby close to public travel and sell the following described highway, subject to rights of access granted by other legislation:
