## BY-LAW NO.16-2015 OF THE TOWN OF VERMILION IN THE PROVINCE OF ALBERTA

## BEING A BY-LAW OF THE TOWN OF VERMILION, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE RATES OF TAXATION FOR ALL PURPOSES FOR THE YEAR 2016

WHEREAS, the estimated expenditures for the Town of Vermilion for the 2016 calendar year for all purposes total \$26,444,450 (including amortization) as shown by the estimates approved by the Council at the May 3, 2016 council meeting, and;

WHEREAS, the probable revenue from all sources other than taxation is estimated at \$17,780,107 as shown by the said estimates, thus leaving a balance of \$6,486,343 to be raised by taxation;

WHEREAS, shown on the following table is the assessed value of all lands and improvements, municipal expenditures, requisitions and respective tax rates for the Town of Vermilion:

NOW, THEREFORE, under the authority and subject to the provisions of the Municipal Government Act, the Council of the Town of Vermilion, in the Province of Alberta, DULY ASSEMBLED ENACTS AS FOLLOWS:

1. THAT, the Director of Finance and Administration is hereby authorized to levy on the assessed value of all land and improvements as shown on the assessment roll of the Town of Vermilion at the above stated rates of taxation for 2016.
