## BY-LAW NO.10-2017 OF THE TOWN OF VERMILION IN THE PROVINCE OF ALBERTA

## BEING A BY-LAW OF THE TOWN OF VERMILION, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE RATES OF **TAXATION FOR ALL PURPOSES FOR THE YEAR 2018**

WHEREAS, the estimated expenditures for the Town of Vermilion for the 2018 calendar year for all purposes total \$39,936,224 (including amortization) as shown by the estimates approved by the Council at the April 24, 2018 council meeting, and;

WHEREAS, the probable revenue from all sources other than taxation is estimated at \$33,097,362 as shown by the said estimates, thus leaving a balance of \$6,838,862 to be raised by taxation;

WHEREAS, shown on the following table is the assessed value of all lands and improvements, municipal expenditures, requisitions and respective tax rates for the Town of Vermilion:
