BY-LAW NO. 11-2018 OF THE TOWN OF VERMILION IN THE PROVINCE OF ALBERTA

BEING A BY-LAW OF THE TOWN OF VERMILION TO ESTABLISH ALTERNATIVE METHODS FOR **ADVERTISING STATUTORY NOTICES**

WHEREAS, pursuant to Section 606 of the Municipal Government Act R.S.A 2000 c.M-26 as amended or repealed and replaced from time to time, a Council must give notice of certain By-Laws, resolutions, meetings, public hearings, or other things by advertising in a newspaper or other publication circulating in the area, mailing or delivering a notice to every residence in the affected area, or by another method provided for in a By-Law under Section 606.1;

AND WHEREAS, pursuant to Section 606.1(1) of the Municipal Government Act R.S.A 2000 c.M-26 as amended or repealed and replaced from time to time, a Council may, by By-Law, provide for one or more methods, which may include electronic means, for advertising proposed By-Laws, resolutions, meetings, public hearings, or other things referred to in Section 606;

AND WHEREAS, the Council is satisfied that the advertising method set out in this By-Law is likely to bring matters advertised by that method to the attention of substantially all residents in the area to which the By-Law, resolution, or other thing relates or in which the meeting or hearing is to be held;

NOW THEREFORE, the Council of the Town of Vermilion, duly assembled, hereby enacts as follows:

TITLE 1.

This By-Law may be cited as the, "Alternative Public Notification By-Law".

ADVERTISING METHOD

Any notice required to be advertised under Section 606 of the Municipal Government Act R.S.A 2000 c.M-26 as amended or repealed and replaced from time to time, of a By-Law, resolution, meeting, public hearing, or other thing may be given, in accordance with the timelines prescribed in Section 606, electronically by:

- a. posting the notice prominently on the Town of Vermilion's official website; and/or
- b. posting the notice prominently on any of the Town of Vermilion's official social media sites; and/or
- c. posting the notice prominently on the bulletin board provided for that purpose in the following municipal facilities:
 - Arena or Stadium; and

ii. Administrative Office.
This By-Law comes into effect upon receiving third reading.
